General Guide line for entry to RRCAT

All the InPAC-09 invited Speakers, Guests, Participants & Industry Exhibition personnel are hereby informed that Raja Ramanna Centre for Advanced technology, under Department of Atomic Energy is a restricted place for entry in to its premises. Any visitor intending to visit "Conference Venue" need to follow certain procedure as follows:

- 1. All the DAE visitors are requested to display their ID card & must ensure its validity.
- 2. All the participants are requested to display the Conference ID card, which will be issued upon registration to InPAC, all the time during conference.
- 3. Non-DAE visitors are requested to keep with them a valid photo ID card for verification by security at 'Guard House' entry gate RRCAT. This will be checked along with conference ID card.
- 4. Visitors & guests coming with their own transport / taxi must ensure that the driver is holding & carrying a valid driving license. Vehicles with 'Gas Kit' are permitted inside only if they are approved by RTO.
- 5. The vehicle & driver should collect the proper 'Token' card from the very first Security gate at the main colony entry itself.
- 6. Visitors are also requested to note that photo camera, video camera, walkman (Audio), mobile phone with camera, Laptops with in-built camera are not allowed to be carried inside RRCAT.
- 7. Visitors are requested to fill in the enclosed declaration form in duplicate for items intended to be carried inside. It is advised that the forms be kept ready filled before approaching 'Guard House' security section for speedy completion of entry formalities.
- 8. All visitors are requested to adhere to these guidelines strictly to avoid denial for entry.
