Note:

- 1. Facility in-charge will send the radiation processing charges, product dose mapping charges to the client.
- 2. After acceptance of the radiation processing charges, product dose mapping charges the client can proceed for further processing.
- 3. After inquiry, fill the client registration form (Doc. No.- ARPF/OFR/02) as well as furnish the undertaking on client's letter head.
- 4. After generation of client registration number, fill the product registration form (Doc. No. -ARPF/OFR/03) and send six number of dully packed boxes for pre-irradiation dose mapping and generating the process specifications.
- 5. ARPF will conduct volumetric dose mapping and optimize the process parameters, packaging dimension, weight and product orientation to deliver the dose within the specified limits, A unique product dose mapping (PDM) number shall be issued for the product and the will be communicated to the client with process specification (box dimension, weight of box, product orientation inside box, labeling on box etc). PDM is a destructive process in which product may be irradiated repeatedly and after repeated exposures the product become unusable. Client shall not claim for any loss/ return of material/ product sent for PDM
- 6. After process optimization, one box out of six boxes will be irradiated to meet the specified irradiation requirement and will be handed over to the client for performing the sterility test and confirming the process of sterilization. Report of sterility test will be submitted to the ARPF. In case additional number of boxes are required for performing sterility test, additional number of boxes can be included in the consignment.
- 7. For regular irradiation, the client shall fill the order registration form (Doc. No. ARPF/OFR/04) in duplicate & send with your products. The second copy of order registration form will be handed over to you after allotting an order registration no. with tentative date of delivery of radiation processed product.
- 8. An irradiation certificate is issued for each lot of the product irradiated at the facility.
- 9. All the forms like inquiry form, client registration form, registration of client product for irradiation form, and order registration form are available at ARPF office.
