INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING

PART A: GUIDELINES FOR E-TENDERING :-

1.	It is mandatory for all the applicants to have class-III digital signature certificate from any of the licensed Certifying Agency to participate in e-tendering
2.	In order to participate in online e-tendering process, it is mandatory for the applicants to have user ID & password to get access to the website www.tenderwizard.com/DAE . The applicants have to get registered their firm / company with the service provider, M/s ITI Limited for user ID & password. The registration shall be done by paying an annual registration fees to M/s ITI Limited and completing other formalities as mentioned in website. Validity of online registration is for one year from date of its issuance and be subsequently renewed. 3.	The applicants, who have already obtained such valid user ID and password from M/s ITI Limited, for any other work of DAE, need not obtain fresh user ID and password for the purpose of participation in the present tender.

5.	The tender shall be submitted online in the prescribed format before the date and time as mentioned in NIT. No other mode of submission is acceptable.
6.	The applicants have to upload the details of DD towards the cost of tender fees and processing fees, before the last date & time and download the tender documents from the e-tendering portal only, otherwise, it will not be possible for them to upload the tender on the e-tendering portal. Note : Downloading the tender documents without confirmation of payment details on web site :www.tenderwizard.com/DAE shall not be valid and rejected summarily Tenderers are advised to upload their documents well in time, to avoid last minutes rush on the server or complications in uploading. RRCAT, in any case, will not be responsible for any type of problem in uploading the documents. No hard copies for tender submission shall be entertained.

7.	Online submission of the tender document after the due date and time shall not be permitted. Time being displayed on e-tendering portal of RRCAT shall be final and binding on applicant. No hard copies for tender submission shall be entertained.

10	Bidders may please note the following also regarding taxes and other liabilities etc:
	(i) This work comes under Works Contract . Taxes applicable for such contracts must therefore be included in the quoted rates. (ii) The contractor should be registered as mandated in the law relevant to GST. (ii) The Goods & Services Tax (GST) as applicable in "individual items as well as overall offer" need to be included in the quoted rates/tender offer. Department shall not entertain any claim pertaining to GST,WCT etc. (iii) Labour Welfare Cess @ 1 % of gross value of work done shall be deducted from each running bill & final bill. (iv) Applicable, income tax/corporation tax, cess, security deposit etc shall be deducted from each running bill & final bill. (v) The bidder must possess valid EPF & ESIC registration as per relevant laws. The bidders need to deposit EPF&ESIC with appropriate authority. The reimbursement for the same shall be made upon submission of satisfactory & genuine documentary evidence. The bidder therefore need not consider EPF & ESIC in the quoted rates. 1.2	Should have satisfactorily completed the works as mentioned below during the last seven years ending on the last day of the month previous to the one in which the tenders are invited: d) Three similar works each costing not less than Rs 4.80 lakh. e) Two similar works each costing not less than Rs 7.20 lakh. f) One similar work costing not less than Rs 9.60 lakh.. Important Note : <ul style="list-style-type: none"> • Similar work shall mean : Miscellaneous of Civil works. • Cost of work shall mean gross value of the completed work including the cost of materials supplied by the Client, but excluding those supplied free of cost. The value of executed works shall be brought to the current costing level by enhancing the actual value of work at a simple rate of 7% per annum; calculated from the date of completion to the last date of receipt of applications for tender.
1.3	Should have had average annual financial turnover of Rs. 12.00 lakh on construction works during the last three years ending 31st March, 2017. (Scanned copy of Certificate from CA to be uploaded)
1.4	Should not have incurred any loss in more than two years during the last five years ending 31st March, 2017.
1.5	Should have valid bank solvency of minimum of Rs.4.80 lakh not older than 25.02.2017.

2	<p>The intending bidder must read the terms and conditions as per "SECTION – 1: NOTICE INVITING TENDERS" OF "CONDITIONS AND CLAUSES OF CONTRACT – 2008" carefully. 4	The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/DAE free of cost. 5	The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards cost of tender document and EMD in favour of "PAY AND ACCOUNTS OFFICER, RRCAT, INDORE" and Processing Fee in favour of "ITI LIMITED, NEW DELHI" and other documents as specified.
6	On opening date, the contractor can login and see the bid opening process.
7	Certificate of Financial Turn Over: At the time of submission of bid, contractor may upload Undertaking / Certificate from CA mentioning Financial Turnover of last 3 years or for the period as specified in the bid document.
8	Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in YELLOW colour and the moment rate is entered, it turns SKY BLUE . In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0" . Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
9	In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
10	The Department reserves the right to accept / reject any prospective application without assigning any reason thereof.
11	<p>Short listing of the agencies shall be subject to thorough verification of their credentials by RRCAT. After opening of Part 'A' of tender Chief Engineer shall constitute an inspection team which will visit selected worksites of ongoing/completed works of the tenderers to evaluate the capability of the tenderers based on the following.</p> <ol style="list-style-type: none"> Financial capability and their turnover during the last 5 years. Technical capabilities of the company in the light of subject work. Nature of works executed by the tenderer during last 7 years. Organizational structure of the company. Necessary Resource required by company to carry out the subject work. Time & quality consciousness. Tendency of the company with regard to making extraneous claims and disputes. 12	IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in RRCAT.
13	NO MODIFICATIONS IN THE TENDER SHALL BE ALLOWED AFTER OPENING OF PART 'A'.

14	<p>If any tenderer withdraws his tender within the validity period and before award of work whichever is earlier or make any modifications in terms and conditions of the tender which are not acceptable to the department, then the government shall without prejudice to any right or remedy, be at liberty to forfeit 50% (Fifty percent) of the earnest money absolutely.</p> <p>Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.</p>

The PVC will be valid for three years.</p> <p>In case of receipt of any adverse charter and antecedent remarks/notification against the contractor/company/firm/proprietor and/or his contract personnel, consequent to the security vetting, RRCAT reserved absolute right to terminate the contract forthwith without assigning reason/show cause notice. Under the circumstances the contractor will have no right to claim good any loss/liability that may be incurred as consequence to the above action initiated by RRCAT.
