Chief Engineer, Raja Ramanna Centre for Advanced Technology, P.O. RRCAT, Indore, on behalf of President of India are hereby invited online item rate tender through e- Tendering mode in two parts, i.e. Part 'A' – Technical Bid and Part 'B' – Financial bid from eligible contractors on approved list of CPWD, MES, Railways, State PWDs, Public Sector Undertakings of Central or State Governments/Central Autonomous bodies or those having adequate experience and capabilities to execute similar works of such magnitude in Department of Atomic Energy (DAE). The details are given below:

INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING

PART A: GUIDELINES FOR e-TENDERING :-

1. It is mandatory for all the applicants to have class-III digital signature certificate from any of the licensed Certifying Agency to participate in e-tendering.
2. In order to participate in online e-tendering process, it is mandatory for the applicants to have user ID & password to get access to the website www.tenderwizard.com/DAE . The applicants have to get registered their firm/company with the service provider, M/s ITI Limited for user ID & password. The registration shall be done by paying an annual registration fees to M/s ITI Limited and completing other formalities as mentioned in website. Validity of online registration is for one year from date of its issuance and be subsequently renewed. 3. The applicants, who have already obtained such valid user ID and password from M/s ITI Limited, for any other work of DAE, need not obtain fresh user ID and password for the purpose of participation in the present tender.
4. The services for e-tendering in RRCAT/DAE is provided by M/s ITI Ltd., Tender wizard Help Desk Centre, B-1/5A, 2nd Floor Main Nazafgarh Road, Near Janakpuri Metro Station (East) Janakpuri, NewDelhi - 110058, Fax No. : 91-11-25618721 Ph. No. : 011-49424365, e- mail : daehelpdesk@etenderwizard.com
5. The tender shall be submitted online in the prescribed format before the date and time as mentioned in NIT. No other mode of submission is acceptable.
6. The applicants have to upload the details of e-payment of processing fees, before the last date & time and download the tender documents from the e-tendering portal only, otherwise, it will not be possible for them to upload the tender on the e-tendering portal.

Note : Downloading the tender documents without confirmation of payment details on web site : www.tenderwizard.com/DAE shall not be valid and rejected summarily

Tenderers are advised to upload their documents well in time, to avoid last minutes rush on the server or complications in uploading. RRCAT, in any case, will not be responsible for any type of problem in uploading the documents. No hard copies for tender submission shall be entertained.

7. Online submission of the tender document after the due date and time shall not be permitted. Time being displayed on e-tendering portal of RRCAT shall be final and binding on applicant.
8. The tenderers are advised to submit their documents on line well before the due date & time. RRCAT shall not be responsible for any delay in submission of documents for any reason including server and technical problems.
9. In case of any problem with the submission of the online tender document, the applicant may have the assistance of help desk or use the help manual given on the said website or mobile and e-mail mentioned above.

PART C : TENDER REQUIREMENTS FOR ELIGIBILITY, CONDITIONS & INSTRUCTIONS :-

1	Contractors who fulfill the following requirements shall ONLY be eligible to apply. (Joint ventures are not accepted).
1.1,	Proof of registration with Government/Semi Government organizations like CPWD, MES, BSNL, Railways, State PWDs etc. in appropriate class OR having experience in execution of similar nature of works.
1.2	Should have satisfactorily completed the works as mentioned below during the last seven years ending 31.03.2017. Three similar works each costing not less than ₹ 2.176 lakh or Two similar works each costing not less than ₹ 3.264 lakh or One work similar costing not less than ₹ 4.352 lakh Important Note : <ul style="list-style-type: none"> • Similar work shall mean : Providing & fixing of structural glazing with sandwiched panels of reflective heat strengthened tinted glass. • Cost of work shall mean gross value of the completed work including the cost of materials supplied by the Client, but excluding those supplied free of cost. The value of executed works shall be brought to the current costing level by enhancing the actual value of work at a simple rate of 7% per annum; calculated from the date of completion to the last date of receipt of applications for tender.
1.3	Should have had average annual financial turnover of ₹ 5.44 lakh of the estimated cost during the immediate last three consecutive financial years ending 31st March, 2017. (Scanned copy of Certificate from CA to be uploaded).
1.4	Should not have incurred any loss in more than two years during available last five consecutive years ending 31st March, 2017. (balance sheet duly certified and audited by CA to be submitted).
1.5	Should have minimum solvency of ₹ 2.176 lakh (not older than 23.11.2016).
1.6	List of works in hand & List of similar works carried out by them for last 7 years indicating : i) Agency for whom executed, ii) Value of work, iii) Completion time as stipulated and actual, or present position of the work.
1.7	List of construction plant, machinery, equipments, accessories & infrastructure facilities possessed by the agency to complete the work in time.

1.10	UNDERTAKING as under:- I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in DAE in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the department shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid).
2	The intending bidder must read the terms and conditions as per "SECTION – 1: NOTICE INVITING TENDERS" OF "CONDITIONS AND CLAUSES OF CONTRACT – 2008" carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required. Department reserves the right of Non-consideration of Tender documents of the agencies who are not fulfilling the NIT stipulations and /or having adverse report on the works carried out by them in the past.
3	Information and Instructions for tenderers posted on website shall form of tender document.

4	The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/DAE free of cost. The detailed NIT can also be viewed & downloaded from www.rrcat.gov.in .
5	The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favour of "PAY AND ACCOUNTS OFFICER, RRCAT, INDORE" and Tender Processing Fee in favour of "ITI LIMITED, NEW DELHI" and other documents as specified.
6	On opening date, the contractor can login and see the bid opening process.
7	Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in RED colour and the moment rate is entered, it turns SKY BLUE . In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
8	Certificate of Financial Turn Over: At the time of submission of bid, contractor may upload Undertaking / Certificate from CA mentioning Financial Turnover of last 3 years or for the period as specified in the bid document.
9	The Department reserves the right to accept/reject any prospective application without assigning any reason thereof. The department does not bind itself to accept the lowest tender and reserves to itself the authority to reject any or all of the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.
10	IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in RRCAT.
11	Canavassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
12	Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by RRCAT.
13	TAXES : i). (i) This work comes under Works Contract. Taxes applicable for such contracts must therefore be included in the quoted rates. (ii) The contractor should be registered as mandated in the law relevant to GST. (iii) The Goods & Services Tax (GST) as applicable in individual items need to be included in the quoted rates. Department shall not entertain any claim pertaining to GST. (iv) Labour Welfare Cess @ 1 % of gross value of work done shall be deducted from each Running bill & final bill. (v) Income/Corporation tax, cess etc shall be deducted from each Running bill & final bill. vi). Any other taxes/cess as per Government directives shall be deducted from each bill paid to the contractor, from time to time. vii). Contractor shall be responsible for making payment of wages through Bank/Cheque before the expiry of 7 days from the last day of wage period. No other mode of payment shall be acceptable.
14	If any tenderer withdraws his tender within the validity period and before award of work whichever is earlier or make any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall without prejudice to any right or remedy, be at liberty to forfeit 50% (fifty percent) of the Earnest money absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.
15	In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
16	The successful bidder whose tender is accepted will be required to obtain Police Verification Certificate (PVC) issued by Office of the Superintending of Police of the concerned district at his own cost for all his workmen i.e. Engineers, Supervisors and labourers to work inside RRCAT and should quote accordingly. The PVC will be valid for three years. In case of receipt of any adverse charter and antecedent remarks/notification against the contractor/

company/firm/proprietor and/or his contract personnel, consequent to the security vetting, RRCAT reserves absolute right to terminate the contract forthwith without assigning reason/show cause notice. Under the circumstances the contractor will have no right to claim good any loss/liability that may be incurred as consequence to the above action initiated by RRCAT. RRCAT also reserves the right to forfeit in part/full performance guarantee and/or security deposit in possession of the Government for failure on the part of the contractor to abide/adhere to the Security instruction issued by DAE/RRCAT from time to time.

NOTE : PROSPECTIVE AGENCIES SHALL SATISFY THEMSELVES OF FULFILLING ALL THE NIT CRITERIA BEFORE SUBMISSION OF TENDER. DEPARTMENT RESERVES THE RIGHT OF NON CONSIDERATION OF TENDER OF THE AGENCIES NOT FULFILLING THE STIPULATED CRITERIA.
