



Sub:- Appointment of Retired Senior Private Secretaries on outsourcing basis in ITAT- reg.

Services of suitable candidates for the post of Senior Private Secretary in the Pay Scale of Rs. 9300-34800 with Grade Pay Rs. 4800/- since revised w.e.f. 01.01.2016 to Rs. 47600-1,51,100 (Level-8) are required in the office of the Income Tax Appellate Tribunal on outsourcing basis. Therefore, retired Sr. P.S. (retired during last 4-5 years from ITAT or other offices under central/state govt.) are requested to contact and forward willingness to the Assistant Registrar, ITAT, Indore for further necessary action. The potential candidates shall be appointed upto 31st Dec., 2022 which may be extended further subject to approval of the Ministry of Law and Justice for the same.

- 2) The selected Officers will have the option to draw pay on contract as per rules.
- 3) The selected Officers are liable to be transferred to any Benches of the Tribunal located at various places in India if exigencies so warrant.
