Notes:

1. Pathological, Bacteriological, Radiological or other methods of examination for the purpose of diagnosis shall be referred by AMA to the Diagnostic Centre empaneled by RRCAT.
2. The CHSS beneficiaries are allowed to purchase medicines themselves and claim reimbursement.
3. The AMA shall not prescribe items in the nature of foods, tonic having more food value, disinfectants or cosmetic nature like Medicated Shampoo, Talcom Powder, Oil, Sunscreen lotions or similar preparations.
4. The AMA cannot refer any CHSS beneficiary to any of the empaneled hospitals of RRCAT for consultation / procedure / treatment. In case such need arises, The CHSS beneficiary should contact RMC doctors, who in turn will give referral to the beneficiary for taking the required treatment from the empaneled hospital.
5. Beneficiaries are requested to not consult any previously empanelled AMA who is not included in the above list.
6. The AMAs shall extend their consultation to the RRCAT CHSS beneficiary only for the specialty for which they are empaneled by CGEWCC, Indore.
7. The claim for the consultation from the AMA who is not included in the above list shall not be entertain.
