Dr. (Smt.) Abha Uppal, SO/G and Shri Dinesh Chand Meena, AO-III(A-1) could not attend the meeting.

- 2. At the outset, the Convener welcomed the members. Chairman informed that the main objective of Scheme for compassionate appointment is to provide appointment to a dependent family member of a Government servant dying in harness or who is retired on medical grounds, thereby leaving his family in penury and without any means of livelihood and to relieve the family of Government servant from financial destitution and to help it get over the financial destitution. The Scheme for compassionate appointment envisaged consideration of applications for compassionate appointment only to really deserving cases while recommending case for compassionate appointment.
- 3. Against the two vacancies for the recruitment year 2021, eight (8) applications have been received from the dependent of deceased employees for compassionate appointment. The Committee has taken into consideration the reports submitted by Welfare Committee appointed by Director, RRCAT vide Office Order No. 4/6/2021-भर्ती/Rect/869 dated 27/10/2021. The Welfare Committee visited to the residences of deceased employees and telephonic conversation had by the Welfare Committee member where visit was not possible.

4. The relevant particulars of the deceased employee, the name of the applicant and his/her relationship with the deceased employee are as below:

5. The Committee decided to consider the most deserving applications for compassionate appointment on the basis of relative merit points system issued by DAE vide OM No.24/6/2014-SCS/6040 dated 06/05/2022 read with guidelines issued by DoPT on Compassionate Appointment vide OM No.14014/1/2022-Estt.(D) dated 02/08/2022 endorsed by DAE vide endorsement No.29/2/2021-SCS/E-File/11753 dated 13/09/2022. Accordingly, the relative merit point system has been placed before the Committee as per the format endorsed by the said DAE OM on the basis of details furnished by the applicants and financial benefits obtained from Establishment Cell, RRCAT and Accounts Section, RRCAT. The relative merit points includes various factors such as family pension sanctioned at normal rate, grant of terminal benefits paid, assets and liabilities on the dependent family members, number of dependent family members.

The detailed screening of each application have been carried out as under:

5.1 Mr. Anshul Dawar S/o Late Shri Ashok Davar, Ex-Tech/C:

The following points were observed by the Committee:

i. The family details :

- a) The family of Late Shri Ashok Davar consists of wife, major unmarried daughter (19 years) and major unmarried son (20 years).
- b) None of the children is school going children.
- c) None of the children is mentally challenged.

ii. Left out service of deceased employee:

Date of birth of Late Shri Ashok Davar is 10/06/1977, hence his date of retirement would be 30/06/2037. Late Shri Parmar died on 07/10/2021. Hence his left out service was 15 Years, 8 months and 24 days as on

date of death.

iii. Financial details:

- a) Smt. Manju Davar W/o Late Shri Ashok Davar getting Enhanced Family Pension @ ₹ 17150/- per month (Normal Family Pension @ ₹ 10290/- per month).
- b) The amount received by the family of Late Shri Davar are (i) ₹ 8,98,660/- as Death Gratuity and (ii) ₹ 37,326/- as CGEGIS.
- c) The family of deceased employee is residing in government quarters and doesn't have any house anywhere.
- d) There is no other source of income in the family.

f) The committed liability on the deceased government servant on repayment of housing loan is NIL as per the details obtained from dependent family member.

iv. Applicant details:

Considering all the dependents family members, grant of terminal benefits, left out service, owning house anywhere, labilities etc. against relative merit point system as a *step-in-aid*, Mr. Anshul Dawar's case got 77 points out of 100 points. Based on the above facts, the Committee considered his case as a most deserving for Compassionate Appointment and recommended him for the post of Work Assistant /A in Level-1 of Pay Matrix.

5.2 Mr. Lucky Parmar S/o Late Shri Vishnu Parmar, Ex-WA/A:

The following points were observed by the Committee:-

i. The family details :

- The family of Late Shri Vishnu Parmar consists of dependent mother, wife, major unmarried daughter (24 years) and major unmarried son (22 years).
- b) None of the children is school going children.
- c) None of the children is mentally challenged.

ii. Left out service of deceased employee:

Date of birth of Late Shri Vishnu Kumar Parmar is 13/07/1970, hence his date of retirement would be 31/07/2030. Late Shri Parmar died on 22/04/2021. Hence his left out service was 9 Years, 3 months and 8 days as on date of death.

None of the children is mentally challenged.

Date of birth of Late Shri Shiv Bachan is 06/01/1971, hence his date of retirement would be 31/01/2031. Late Shri Sharma died on 30/03/2021. Hence his left out service is 9 Years, 10 months and 01 day as on date of death.

5.4 Mr. Mandeep Singh S/o Late Shri Manjeet Singh, Ex-Sr.Techn/J:

The following point were observed by the Committee:

i. The family details:

- a) The family of Late Shri Manjeet Singh consists of wife, minor unmarried son (17 years) and major unmarried daughter (21 years).
- b) None of the children is school going children.

c) None of the children is mentally challenged.

ii. Left out service of deceased employee:

Date of birth of Late Shri Manjeet Singh is 03/02/1968, hence his date of retirement would be 29/02/2028. Late Shri Manjeet Singh died on 18/04/2021. Hence his left out service is 6 Years, 10 months and 12 days as on date of death.

However, based on the above facts, **the Committee rejected his case for Compassionate Appointment** as the family is getting enough income from pension, with lesser liability.

However, based on the above facts, **the Committee rejected her case for Compassionate Appointment** as the family is getting enough income from pension, with lesser liability.

However, based on the above facts, the Committee rejected his case for Compassionate Appointment as the family is getting enough income from pension, with lesser liability.

Dr. Neetu Khatwani W/o Late Shri Harish Khatwani, Ex-SOG: 5.7

The Committee noted that Dr. Nitu Khatwani initially requested for Compassionate appointment vide application dated 16/09/2021. Later vide application dated 07/09/2022, she requested for Compassionate Appointment to her son Master Hanish Khatwani, who is 8 years old, after completing 18 years of age.

The Committee has gone through the guidelines issued by DoPT and DAE on the subject matter and unanimously agreed that the compassionate appointment scheme envisaged for providing immediate relief to the family Page 7 of 8

Government servant hence there is no provision for deferring the case for appointment in future.

5.8 Smt. Pathan Ashiya Khan W/o Late Shri Pathan Imrankhan B, Ex-UDC: The Committee noted that Smt. Pathan Ashiya Khan initially requested for Compassionate appointment vide application dated 03/06/2021. Later vide application dated 09/08/2022 (sent via e-mail), she requested for Compassionate Appointment to her son Master Muhammad Humza Khan, who is 2 years old, after completing 18 years of age.

The Committee has gone through the guideline issued by DoPT and DAE on the subject matter and unanimously agreed that the compassionate appointment scheme envisaged for providing immediate relief to the family members who are suffering from financial destitution due to death of Government servant hence there is no provision for deferring the case for appointment in future.

6. In view of the above discussion the Committee concluded following:

Based on the above relative merit point system and availability of 02 vacancies in Work Assistant/A, the Committee recommended to consider the case of (1) Mr. Anshul Davar and (2) Mr. Lucky Parmar for Compassionate Appointment against the vacancies for recruitment year 2021 for the post of Work Assistant/A (Level-1 of Pay Matrix). The committee has also recommended to consider the case of Mr. Suryadeep Jaiswar for Compassionate Appointment against the vacancies for recruitment year 2022 and for the year 2021 subject to denial by any one above (i.e. Mr. Anshul Davar and Mr. Lucky Parmar). Further, the cases of (1) Mr. Mandeep Singh, (2) Kum. Meenal Sharma and (3) Mr. Nitin Patil got points below 50 and hence their cases for compassionate appointment may be rejected.
