**MINUTES OF MEETING OF COMPASSIONATE APPOINTMENT SCREENING  
COMMITTEE HELD ON 13/02/2025 AND 03/03/2025**

The meeting of Compassionate Appointment Screening Committee for considering cases for the vacancies of year 2022 and 2023 was held on 13.02.2025 and 03.03.2025 at 1100 hours in the Interview Room, Administration Building, RRCAT.

2. At the outset, the chairperson welcomed the members. There are four (04) fresh applications and 04 old applications were also carried forwarded for consideration. All put together, there are 08 cases to be considered against 03 Direct Recruitment vacancies in Group 'C'.

3. The Committee gone through the conditions stipulated in DAE OM No. 24/6/2014-SCS/6040 dated 06.05.2022 alongwith guidelines issued by DoPT on Compassionate Appointment vide OM No. 14014/1/2022-Estt(D) dated 02.08.2022 endorsed by DAE vide endorsement no. 29/2/2021-SCS/E-file/11753 dated 13.09.2022. As per the said OM, the relative merit points which include various factors such as family pension sanction at normal rate, grant of terminal benefits (Gratuity, CGEGIS Insurance) paid, assets and liabilities on the dependent family members, number of dependent family members etc. were meticulously arrived by the Committee.

4. The details of fresh cases and earlier cases are placed as Annexure-I and Annexure-II. Details are tabulated below:



