#### 1) GENERAL CONDITIONS FOR THE INFORMATION OF APPLICANTS

#### Age limit as on last date for receipt of application:

- 1.1 Post Code-I Between 18 and 38 years including age relaxation for OBC Candidates.
- **1.2 Post Code-II** Between 18 and 27 Years for General candidates and 18 and 30 Years for OBC candidates.
- 1.3 Post Code-III & IV Between 18 and 30 Years including age relaxation for ST Candidates.

#### In addition to the above, the following age relaxation are also applicable :

- a) Relaxation of the upper age limit of five years shall be admissible to children/family members of those who died in the 1984 riots. Proof to the effect that they have been affected by 1984 riots should be furnished.
- **b) Ex-servicemen :** After deducting the period of armed force service from the actual age of the candidate the resultant age should not exceed the maximum age limit prescribed for the post by more than three years.
- c) Govt. Servants : In accordance with orders of the Central Government.
- **d**) Relaxation in the upper age limit of 5 years shall be admissible to all persons who had ordinarily been domiciled in Kashmir division of the state of Jammu & Kashmir during the period from 1<sup>st</sup> day1) of January 1980 to 31<sup>st</sup> day of December, 1989 provided that the relaxation in the upper age limit for appearing at any examination shall be subject to the maximum number of chances permissible under the relevant rules.

**NOTE :** Only date of birth indicated in school leaving certificate or equivalent certificate will be accepted. No subsequent request for change shall be granted.

2) Before applying, the candidate should ensure that he/she fulfills all the eligibility conditions and minimum required educational qualification criteria mentioned in this advertisement. The candidate would be admitted to various stages of the recruitment process based on the information furnished by the candidate in his/her application. Only a summary scrutiny of the application would be made before the final stage of the recruitment process and detailed scrutiny of the eligibility of the candidate would be done only at the final stage of the recruitment process. As such, the candidature of the applicant shall remain provisional till detailed scrutiny is undertaken and the candidate is found eligible in all respect. RRCAT would be at liberty to reject any application at any stage of the recruitment process if the candidate is found ineligible for the post. The decision of RRCAT shall be final in deciding the eligibility of the candidate. The mere

- **3)** Interview will be held at RRCAT, Indore. SC/ST Candidates called for Trade test/Skill Test/Interview will be paid Travelling Allowance to and fro by Sleeper Class (as per rules). However, Travelling Allowance is not admissible to those SC/ST candidates who are already in service in Central/State Government services, Central/State Government Corporation, Public Sector Undertakings, Local Government Institutions and Panchayats and the concession availed from Railways, if any, for undertaking journey for attending written examination / interview.
