<sup>\*</sup>One post reserved for Orthopaedically Handicapped (OH) for post Code II-1 only. Orthopaedically Handicapped means have a minimum of 40% of physical defect or deformity which causes an interference with the normal functioning of the bones, muscles and joints.

\*\*One post reserved for Hearing Handicapped (HH) for post Code II-1 or II-5A or II-6 only. Hearing Handicapped means having hearing loss more than 60 decibels in the better ear (profound impairment) or total loss of hearing in both ears.

Note: ITI certificate should be from the Government recognized institution.

<u>Important</u>: Recruitment rules for Category-II prescribe the eligibility criteria in terms of minimum qualification & percentage of marks. However, if the candidates with higher qualifications opt for selection to the post prescribed for lower qualification, they will not be denied in principle the opportunity of their recruitment. Such candidates who are already overqualified or likely to complete the process of acquiring higher qualification after their recruitment with not less than 60% marks will not be considered for the purpose of Additional Qualification based promotion for the specified period while in service as follows:

- a) B.Sc./Diploma in Engineering 6 Years
- **b)** B.Tech./AMIE/M.Sc. 8 Years
- c) M.Tech./Ph.D. 10 Years

#### **Age Limit:**

18 years (minimum) and 27 years (maximum) as on 10<sup>th</sup> August 2015

# In addition to the above, the following age relaxation is also applicable:

- a) Relaxation of the upper age limit of five years shall be admissible to children/family members of those who died in the 1984 riots. Proof to the effect that they have been affected by 1984 riots should be furnished.
- b) <u>For persons with disabilities (Applicable for Post Code II-1 or II-5A or II-6 only)</u>:

  18 years (minimum) and 37 years (maximum) as on 10<sup>th</sup> August 2015
- c) Relaxation in the upper age limit of 5 years shall be admissible to all persons who had ordinarily been domiciled in Kashmir division of the state of Jammu & Kashmir during the period from 1<sup>st</sup> day of January 1980 to 31<sup>st</sup> day of December, 1989 provided that the relaxation in the upper age limit for appearing at any examination shall be subject to the maximum number of chances permissible under the relevant rules.

NOTE: Only date of birth indicated in School Leaving Certificate (SLC) or equivalent certificate will be accepted for J&K applicants. No subsequent request for change shall be granted.

#### **Certificate regarding proof of residence -**

Any person intending to avail of this relaxation of age limit admissible under Central Civil Services and Civil Posts (Upper Age Limit for Direct Recruitment) Rules, 1998, shall submit a certificate from:

i) The District Magistrate in the Kashmir division within whose jurisdiction he/she had ordinarily resided;

or

**ii**) Any other authority designated in this behalf by the Government of Jammu & Kashmir to the effect that he/she had ordinarily been domiciled in the Kashmir division of the state of Jammu & Kashmir during the period from the 1<sup>st</sup> day of January, 1980 to the 31<sup>st</sup> day of December, 1989.

In addition to above Category-II Trainees will be entitled for a one time book allowance of ₹ 1,500/- for purchase of approved books pertaining to their training course.

- (c) <u>Accommodation</u>: Sharing accommodation will be provided in RRCAT Colony on payment of prescribed license fee, electricity/water charges as approved by the Department, subject to availability of accommodation.
- 3. Before applying, the candidate should ensure that he/she fulfills all the eligibility conditions mentioned in advertisement. The candidate would be admitted to various stages of the recruitment process based on the information furnished by the candidate in his/her application. Only a summary scrutiny of the application would be made before the final stage of the recruitment process and detailed scrutiny of the eligibility of the candidate would be done only at the final stage of the recruitment process. As such, the candidature of the applicant shall remain provisional till detailed scrutiny is undertaken and the candidate is found eligible in all respect. RRCAT would be at liberty to reject any application at any stage of the recruitment process if the candidate is found ineligible for the post. The decision of RRCAT shall be final in deciding the eligibility of the candidate. The mere fact that a call letter has been issued to the candidate and allowed to appear in a written test/interview will not imply that his/her candidature has been finally cleared or that entries made by the candidate in his/her application have been accepted as true and correct.

#### 4. Written Examination:

Written examination of one-hour duration will be conducted and will comprise of objective (multiple) type questions. Candidates should come prepared to stay in Indore for the written test/interview for minimum two days. No accommodation will be provided for these two days to the candidates coming for written examination and interview. The syllabus for the said examination will be based on subjects at SSC/HSC/ITI. Those candidates qualifying in the written examination shall be short-listed for interview on the same or following day.

Final selection and ranking will be on the basis of the performance of the candidates in interview. No weightage will be given for marks scored in the written examination. The decision of this Centre in this regard will be final.

## 5. Scope of Training:

Selected candidates will be given training in the Centre in various aspects of relevant Trades/ Disciplines, as per prescribed syllabi of each Trade/ Discipline and for meeting the stringent requirements of this Centre. The candidates will not have choice/option for any particular training programme/ training place/ final placement.

The candidates may be required to work in round-the-clock shifts, including night shift, during the period of training.

## 6. Grade after successful completion of Training:

Upon successful completion of training, the Stipendiary Trainees (Category-II) will be considered for absorption in one of the following grades depending on their performance during the period of training and interview to be held at the end of the training. Based on the performance during training, additional increments may be given on absorption.

#### 7. Execution of Bond:

Selected candidates will have to execute a bond to complete the training and serve RRCAT, Indore or any of the Constituent Units of Department of Atomic Energy (DAE), if offered appointment after the training, for a period of 3 years after such appointment. A trainee who fails to complete the training or serve the Government for 3 years, if offered appointment, will be liable to pay back to the Government a sum equivalent to entire aggregate amount of stipend received by him/her during the period of training along with interest thereon as per Government Rules.

# 8. How to apply:

(i) Application should be submitted in the pro forma given herewith.

Submission of on-line applications will close one week prior to the last date for receipt of application.

Candidates applying on-line <u>must send signed copy of application</u> (produced using the on-line software) along with copies of relevant certificates to the address mentioned. This hard copy of application must reach on or before last date for receipt of application.

- (ii) Application should preferably be typewritten on A4 size paper.
- (iii) The application and the outer cover should be super scribed as "Application for the Post Code\_\_\_\_\_ of Trade\_\_\_\_\_ against Advertisement No. RRCAT-2/2015".
- (iv) Only one application should be submitted for one post. If a candidate wishes to apply for more than one post, separate application should be submitted for each post.
- (v) Candidates are advised in their own interest to send the application by Speed Post/Registered Post.

#### 9. COPIES OF CERTIFICATES

Candidates should submit along with their application self attested SINGLE COPY of:

- **a)** Certificates pertaining to educational qualifications/experience and technical/professional qualifications (supported by appropriate marksheets indicating the subjects offered at the examinations).
- **b)** Certificate of date of birth (Class 10<sup>th</sup> or 12<sup>th</sup> mark sheet or certificate).
- c) Candidates should submit caste certificates in the prescribed proforma applicable in Central Government Employment, which is uploaded on our website along with this advertisement.
- **d**) Disability certificate from the appropriate authority regarding physical disability (applicable to persons with disability) in the prescribed proforma uploaded on our website along with this advertisement.

# 10. REQUIREMENT OF DISABILITY CERTIFICATE

- i) According to the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 1996 notified on 31/12/1996 by the Central Government in exercise of the powers conferred by sub-section (1) and (2) of Section 73 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996), a disability certificate shall be issued by a Medical Board duly constituted by the Central or a State Government. The Central/State Government may constitute a Medical Board consisting of at least three members, out of which, at least, one member shall be a specialist from the relevant field.
- temporary. The Medical Board shall indicate the period of validity of the certificate where there are chances of variation in the degree of disability. For those who acquired permanent disability, the validity can be shown as permanent. On representation by the applicant, the Medical Board may review its decision having regard to all the facts and circumstances of the case and pass such orders in the matter as it thinks fit.

#### **NOTE:**

- a) Candidates called for written test/interview will be paid Travelling Allowance as per rules. However, Travelling Allowance is not admissible to those candidates who are already in service in Central/State Government services, Central/State Government Corporation, Public Sector Undertakings, Local Government Institutions and Panchayats and the concession availed from Railways, if any, for undertaking journey for attending written examination / interview.
- b) Candidates selected against this advertisement will be trained at RRCAT, Indore. Upon successful completion of training, they are likely to be posted at RRCAT, Indore but are liable to serve in any part of India and in any constituent unit of the Department of Atomic Energy.

- c) The vacancies shown above are provisional and subject to variation. The filling up of vacancies indicated in the advertisement is also subject to the approval of Competent Authority and may not be filled up if decided otherwise in terms of the orders issued by Government from time to time.
- **d)** The nature of duties to be performed by the above categories of employees will involve working in round-the-clock shift duties (including night shift), in operational plants and areas.
- e) Persons who are appointed against the above posts, will be covered under the New Contributory Pension Scheme as notified by the Government of India, Ministry of Finance, Department of Expenditure vide Notification No. F.No.5/7/2003-ECB & PR dated 22.12.2003.
