Only date of birth indicated in Matriculation certificate / Municipal Birth Certificate will be accepted. No subsequent request for change shall be entertained.

Persons domiciled in Kashmir Division of Jammu Kashmir with Disability : Relaxation in upper age limit of 5 years shall be admissible to persons who had ordinarily being domiciled in Kashmir Division of the State of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989 provided that the relaxation in the upper age limit for appearing at any examination shall be subject to the maximum number of chances permissible under the relevant rules. Certificate should be from :-

- i) The district Magistrate within whose jurisdiction he/she had ordinarily resided. **OR**
- ii) Any other authority designated in this behalf by the Government of Jammu & Kashmir to the effect that he/she had ordinarily been domiciled in the Kashmir Division of the State of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989.

Relaxation in Upper age limit of 5 years shall be admissible to admissible to Children/family members of those who died in 1984 riots.

IMPORTANT REQUIREMENT OF PERSON WITH DISABILITIES CERTIFICATE :

- i) According to the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 1996 notified on 31/12/1996 by the Central Government in exercise of the powers conferred by sub-section (1) and (2) of Section 73 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996), a disability certificate shall be issued by a Medical Board duly constituted by the Central or a State Government. The Central/State Government may constitute a Medical Board consisting of at least three members, out of which, at least, one member shall be a specialist from the relevant field.
- ii) The certificate would be valid for a period of 5 years for those whose disability is temporary. The Medical Board shall indicate the period of validity of the certificate where there are chances of variation in the degree of disability. For those who acquired permanent disability, the validity can be shown as permanent. On representation by the applicant, the Medical Board may review its decision having regard to all the facts and circumstances of the case and pass such orders in the matter as it thinks fit.
- iii) Those SC/ST/OBC persons with disabilities selected on their own merit without relaxed standards along with other candidates, will be considered against unreserved vacancies provided the post is identified for the persons with disability of relevant category.

GENERAL INSTRUCTIONS:

- 1. Candidates who have not acquired / will not acquire the educational qualifications as on the closing date of receipt of application will not be eligible and need not apply.
- 2. In case Universities award letter grades / CGPA / OGPA, the same will have to be indicated as equivalent percentage of marks as per the norms adopted by that University. In the absence of the same, the candidature will not be considered for the interview.
- **3.** All unemployed outstation candidates will be paid to and fro travelling allowance of Second class railway fare or bus fare by the shortest route as admissible under rules subject to production of paper tickets and unemployment certificate duly signed by MP/MLA/Gazetted Officer. If concessional tickets are available, reimbursement will be limited to the concessional fare only.
- 4. Applications which are not in conformity with the requirements indicated in the advertisement are liable to be rejected. E.g. applications which are not in the prescribed format, incomplete, unsigned, without photo, not accompanied by the self attested copies of all the marks memos, pass certificates, date of birth certificate, caste certificates, non-creamy layer in case of OBC, proof of residence in case of J&K domiciled candidates etc. No correspondence will be entertained with the candidates not selected for interview / appointment.
- 5. If the post applied for is not indicated on the top of the envelope the same will not be entertained.
- 6. The applicants would be admitted for the interview on the basis of information furnished by them in their application form. They are therefore advised to ensure that they fulfill all eligibility conditions before applying, in case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfill any of the eligibility condition, the candidature of such applicant would be cancelled and no correspondence in this regard would be entertained. Issuance of Call Letter for the interview will not confer any right for appointment. Appointment will be solely subject to fulfillment of all eligibility conditions.
- 7. SC/ST/OBC/PWD Certificates should be as per the prescribed format for employment in Government of India which are also available on RRCAT website.
- 8. The candidates belonging to SC/ST/OBC should clearly indicate the same in the application and should attach proof of the same in specified format, failing which they will be treated as unreserved and subsequent representations for change of community status will not be entertained. In Case of OBC, the certificate should specifically indicate that the candidate does not belong to any of the creamy layers mentioned in DoPT OM No. 36033/1/2013-Estt.(Res.) dated 27.05.2013
- **9.** RRCAT reserves the right to fill up the post or even to cancel / restrict / modify / alter the whole process of recruitment without issuing any further notice or assigning any reason thereof.

- **10.** The filling up of vacancies indicated in the advertisement is also subject to approval of Competent Authority and may not be filled up if decided otherwise in terms of the orders issued by the Government of India from time to time.
- 11. Candidates selected against this advertisement are likely to be posted at RRCAT, Indore but are liable to serve in any part of India and in any constituent unit of the Department of Atomic Energy.
- **12.** Persons working under the Central/State Govt./Public Sector Undertakings/Autonomous Bodies etc. should submit their application routed through proper channel.
